2 SCIENTIFIC AND ANALYTICAL PROGRAM OF IMPROVEMENT OF EDUCATIONAL AND PROFESSIONAL QUALIFICATION OF RESEARCHER



DESCRIPTION AND CONDITIONS

Scientific and analytical program of improvement of educational and professional qualification of scholars (hereinafter referred to as the program) is the educational procedure aimed at stimulation of scientific and analytical creative activity of scholars and high-quality expert appraisal of original scientific papers of the program participants.

From 5 to 7 author's publications with an average expert assessment from 6.0 to 7.5.

Possible qualifications in ascending order: "Researcher of scientific and analytical problems in the field of science", "Master of scientific analytics and discussion rhetoric in the branch of science"; "Expert of scientific analytics and discussion rhetoric in the branch of science", "Grand Expert of scientific analytics and discussion rhetoric in the branch of science".

An additional educational load received by the relevant person in the process of implementing this program is formalized with special clauses to the "Diploma Supplement" and "Europass Mobility"

Formalization of a full package of electronic documents - € 150.0

Formalization and mailing of a full package of paper documents - € 250.0

3 INTERNATIONAL EXAM



DESCRIPTION AND CONDITIONS

The project allows every person concerned, who has completed the full or partial course of higher, professional or further education, to get his or her special qualification (or the new knowledge) assessed by undergoing the international expert certification.

Successful passing of the test of 5 questions. Registration of the electronic "Attestation Certificate of Education Quality"

Additionally: writing and presentation of attestation author's research in order to acquire the qualification "Analyst" of a corresponding educational specialization.

Such work is submitted for expert assessment within the PLATONICK project.

If an applicant's research receives an average expert assessment of at least 6.0 points according to the 10-point system, the analytical attestation is recognized as successfully passed.

The qualification "Analyst" is formalized by the IASHE diploma, as well as the Europass Diploma Supplement and Europass Mobility.

4 MASTER - SCIENTIFIC AND ANALYTICAL EDUCATIONAL PROGRAMS "MASTER OF BUSINESS ADMINISTRATION IN THE FIELD OF SCIENTIFIC ANALYTICS" (MBA-SA) (INCREASE QUALIFICATION IN THE EXCLUSIVE "MINI-MBA" FORMAT)



DESCRIPTION AND CONDITIONS

- Participation in at least 3 international scientific and educational certification conferences on the MBA-SA program throughout the calendar year;
- Expert assessment;
- Publication of author's researches;
- an average expert assessment score of at least 7.0 (according to the 10-point system);
- If a participant scored an insufficient number of points (based on the results of participation in 3 conferences), he has the right to participate in subsequent conferences. This can continue until the overall average score of the expert assessment is consistent with the specified indicator;
- Possibility to use the benefit.

6 "BRITISH DEPARTMENT" – THE PARTNERSHIP FORMAT



DESCRIPTION AND CONDITIONS

The partnership format of the "British Department" program of the IASHE is implemented in the framework of cooperation with higher educational institutions. This program allows a university student to master the educational program of his educational institution as usual, but at the same time to receive a British diploma of the IASHE about additional education in one or more specialized university disciplines.

Algorithm:

- training a student according to the university program;
- attestation in disciplines within the framework of university exams and credits;
- the final academic attestation of the IASHE:
 - a) the student writes a final attestation work;
 - b) assessment of the work by experts of the IASHE;
 - c) to pass the program, an average expert assessment of at least 6.0 points is required.

Based on the results of successful completion of the final certification, the student receives the following educational documents characterizing the acquired competence and educational qualification "Analyst" in the relevant educational problems: European (British) Diploma (Diploma with distinction - if the expert score is not less than 7.5 points), "Europass Diploma Supplement" and "Europass Mobility".

① APPROBATION OF INNOVATIONS



DESCRIPTION AND CONDITIONS

An author draws up a detailed innovative summary of his research (the object of testing) in English and any other language of interethnic communication. The electronic version of the publication of the research includes a sign "request for international approbation" and an innovative summary of the research in two languages selected by the author.

The author's work is considered to have passed international expert approbation if the average score of its expert assessment (in scientific analytics championships) exceeds 7.0 points, and the sign "request for international approbation" is activated by at least three scientists (experts or participants in championships) who are not associated with the author of the research by a common place of work or study.

The Certification Act of the IASHE is issued.

1 SCIENTIFIC - ADDITIONAL PROGRAMS

② TRAINEESHIP (PRACTICE)



DESCRIPTION AND CONDITIONS

There are two kinds of the scientific traineeship (practice) in the Academy. The scientific traineeship has educational nature.

It consists in the presentation by the trainee of three thematically interrelated author's scientific researches in English. If the average expert assessment score of these scientific papers in the field-specific championship in scientific analytics is over 7.0, the scientific traineeship will be considered successful. If the result is over 8.0, the trainee will be additionally granted the qualification "International expert-consultant" in the corresponding branch of science and the diploma of the Academy.

Certificates and Diplomas of the IASHE, "Europass Diploma Supplement", "Europass Mobility" are formalized. The results of the program are additionally confirmed by the publication of the trainee's original researches in the British scientific journals of the IASHE.

The teaching traineeship assumes that the trainee must prepare the original course of video lectures in accordance with rules and standards of the educational project of the Academy called uHive. If this course of lectures is positively appraised by experts and by participants of uHive project, this course of lectures will be included into the educational program of the International Analytical University of Extensive Knowledge, and the trainee will be offered to join the University as the lecturer on the basis of the corresponding contract.

The results of the teaching internship are formalized by the IASHE Certificate and "Europass Mobility".



③ PRACTICAL IMPLEMENTATION OF ORIGINAL INNOVATIONS



DESCRIPTION AND CONDITIONS

The introduction of innovations is carried out through their fixation and presentation in the author's scientific works of researchers, as well as through the borrowing and practical application of such innovations by other scientists.

The Academy practically implements the original innovations in the framework of the PLATONICK project in accordance with the following algorithm:

- At first the link "Requesting international implementation" is added to the electronic version of the corresponding scientific paper.
- The corresponding original scientific paper is considered to have successfully completed the procedure of international implementation, if its average expert assessment score in the scientific and analytical championship is over 7.5, and the link "Requesting international implementation" has been clicked by at least 3 scientists (experts or participants of championships). These scientists must not share the place of work or study with the author of the corresponding paper.

2 SCIENTIFIC - DOCTORAL PROGRAMS

DYNAMIC DOCTORAL PROGRAMS



Dynamic programs assume that an author must submit a significant number of original scientific papers for expert assessment. Quantity and quality of these papers must allow the author accumulate during the year a number of credits required to complete the program (1 - first variant of the program). This specific amount of credits is indicated in the Special "Prize Regulations" of the Academy. Also, the program can be successfully implemented according to the rules of the Regulations "On the doctoral programs" (2 - second variant) or on condition that an applicant obtains the necessary average point for expert assessment of the totality of author's publications in the project (3 - third variant). Any variant of the program that is most acceptable for the applicant can be applied. All scientific papers submitted by the author in the framework of the program must be related to the same scientific branch, but of course can have different topics.

At least 7 participations in conferences during a calendar year or 10 participations during a two-year period; The average attestation score of expert assessment should correspond to the following value for the indicated scientific and analytical degrees (on a 10-point system): — International Doctor of Philosophy and Science Analytics (IDPSA) – more than 7,0 points (or at least 1200 credit prize points); — International Doctor Habilitate of Science Analytics (IDHSA) – more than 7,5 points (or at least 1600 credit prize points); — International Supra Doctor of Science Analytics (ISDSA) – more than 8,0 points (or at least 2000 credit prize points); — International Prima Doctor of Science Analytics (IPDSA) – more than 8,2 points (or at least 2200 credit prize points); — International Grand Doctor of Science Analytics (IGDSA) – more than 8,5 points (or at least 2400 credit prize points)

Diplomas, Europass documents, insignia.



Participation in the program and formalization of an electronic Certificate of the international standard of education quality is free.

Upon successful completion of the program in accordance with the rules of the Regulations "On doctoral programs" participation in such a program, as well as registration and mailing of a full package of paper documents is free.

- Registration of the full package of electronic documents - € 500.0
- Registration and mailing of the full package of paper documents - € 1500.0
- The granting of the privilege - € 1000.0 + € 500.0 for each next doctoral qualification of a higher level, which is awarded on preferential terms (this amount is not refundable to the applicant).

② BIBLIOGRAPHIC DOCTORAL PROGRAMS



Bibliographic scientific and analytical doctoral programs are qualification-related procedures of analysis and recognition of high scientific and educational competence of researchers, who can be characterized by significant activity in publication of their scientific studies, as well as the general productivity and efficiency of scientific creativity. The procedure of international expert assessment of the author's bibliography is being carried out.

The qualifications (degrees):

- Master of scientific and analytical creativity / "biblio" (MSAC/B);
- Doctor of scientific and analytical creativity / "biblio" (DSAC/B).

Bibliographic scientific and analytical doctoral programs can have two different formats: the attestation or certification format and the status format. Depending on the format of the program, the final qualification of the applicant may have one of the following prefixes: status (S) or attestation (A).

Under the attestation format of the program the professional qualitative assessment of the scientific papers published by the scientist in the course of the PLATONICK project is the most important criterion. In this format of the program only scientific papers reviewed by the project experts are taken into account.

The status format of the program is based on the idea that the entire set of scientific publications of the author does not have to be reviewed by experts, because the high quality of these publications cannot be called in question.

Correspondingly, after the successful completion of the attestation format of the program the brand-new doctoral qualification of the applicant is formalized not only by the international diploma, but also by the certification documents of the international Europass system (Europass Diploma Supplement and the Europass Mobility), and the scientific and educational load is calculated in the ECTS credits. The status qualification is only formalized by the doctoral diploma.

In order to successfully complete the bibliographic scientific and analytical doctoral program and to acquire the corresponding qualification, a corresponding person must meet at least the following basic requirements:

Master of scientific and analytical creativity / "biblio" (MSAC/B) must have at least 20 publications. 10 of them must be published in the framework of the PLATONICK project. Under the attestation format of the program the average expert assessment grade of the scientific papers submitted within the PLATONICK project must be 7.0 and higher.

Doctor of scientific and analytical creativity / "biblio" (DSAC/B) must have at least 40 publications. 20 of them must be published in the framework of the PLATONICK project. Under the attestation format of the program the average expert assessment grade of the scientific papers submitted within the PLATONICK project must be 7.5 and higher.

Attestation format of the bibliographic doctoral program also assumes the educational load and the international professional assessment of the level of knowledge and the scientific qualification of the scholar. In the framework of the attestation format of the program in addition to the doctoral diploma, the applicant is provided with the documents of the Europass system.

③ THESIS-BASED (DISSERTATION) DOCTORAL PROGRAMS



Fundamental feature of the mechanism of the thesis-based (dissertation) programs is that the scientific and analytical work of the applicant is related to his or her thesis, which is to be mandatorily reviewed by experts and published.

In the framework of this program its participant must prepare original scientific papers and submit them for expert assessment. Contents of these scientific papers must be directly related to the thesis written by the corresponding researcher.

- The dissertation research (at least 3 sections and 100 pages of text) is published as a monograph in English.
- At least two positive reviews from reputable experts.
- At least 2 articles related to the topic of each section of the dissertation research are published in the PlatoNick project. For a positive passing of the qualification attestation, such works must gain an average assessment score of at least 7.0.

The dissertation program is the most optimal way to obtain the level 1 IASHE doctoral qualification - International Doctor of Philosophy and Science Analytics (IDPSA). But if the number of points obtained by the applicant corresponds to a doctoral degree of a higher level, then such a higher degree is awarded to this person.

① SCIENTIFIC AND ANALYTICAL ACADEMIC PROGRAMS



In our Academy the Academician status is not granted for some former achievements or different kinds of merits. This status must be earned directly in the process of scientific interaction with the Academy.

The following status titles can be acquired within the system of the Academy:

● Corresponding member of the Academy;

● Full member of the Academy - academician.

The status-titles of the Academy can be acquired only by participants of the PLATONICK project, which have earned the following amounts of credits in championships in scientific analytics of the corresponding year:

● in order to become the Corresponding member of the Academy – 1500 credits;

● in order to become the Full member of the Academy – 2000 credits.

Persons applying for the status titles must occupy the prize-winning places in the alpha-championship (within the field specific section) or in the absolute championship (within the scientific branch) of the corresponding year.

The status title must be confirmed annually by earning points (scoring) in the PLATONICK project: the Corresponding member of the Academy – 300 credits; the Full member (Academician) of the Academy – 500 credits.

If a person is able to confirm the status title of the Corresponding member of the Academy for three years in a row, such person will automatically become the Academician.

The title categories of Academicians: the third title category Tropos-Academician (first 3 years of status confirmation); the second title category Stratum-Academician (4-5 years of status confirmation); the first title category Mesos-Academician (6-7 years of status confirmation); the highest title category Therme-Academician (8-9 years of status confirmation); the highest title category Exo-Academician (10 and subsequent years of status confirmation).

The bibliographic scientific and analytical academic programs and the bibliographic scientific and analytical doctoral programs are based on the same principles and basic rules.

2 INTERNATIONAL SCIENTIFIC CONGRESS



International Scientific Congress of the Academy is the permanent interdisciplinary scientific and analytical forum for professional scientists and experts in different fields.

Congress of the Academy is not a one-time event, but an extensive and lasting project, which is implemented in the interactive form. Structurally the Congress is divided into sections, which are connected to the branches of science. Every section is divided into sessions which cover different topics.

The field-specific Congresses are guided by the Curators. These are authoritative scientific and educational organizations or individual scientists. Curators initiate the field-specific Congresses and supervise these events in accordance with the established rules.

During the Congress sessions the discussions between scientists and experts in different fields are arranged. These discussions are aimed at solution of pressing theoretical and practical problems and also at the development of specific recommendations on how to overcome these problems.

Statements and phrases of participants of the Congress are appraised by other participants of the discussion.

As soon as the session comes to its logical end, the curator prepares the Congress Resolution, which must be further approved by its participants. These resolutions are published by the Academy as independent editions, and sent to authoritative organizations working in the respective fields.

Upon the initiative of the third parties, or the clients, the Congresses may function in the mode of the so-called Congress Laboratories. These events are focused on solution of the specific scientific problems stated by the client.

All active participants of the Congress are given personal certificates of the Academy. The three best participants of the session are given the Golden, Silver and the Bronze diplomas, devoted to the world famous scientists, who have made a significant contribution to the development of the corresponding scientific branch.

Any researcher can take part in these intellectual competitions, regardless of his or her formal connections with science, property or social status, age, nationality or the country of residence.

There is only one basic requirement to participants of championships: an applicant must write a grammatically correct and logically grounded original scientific paper related to problems of modern science. That is why only diligent and goal-seeking participants, who respect knowledge and think in a progressive and creative way, can reach success in our project. Probably, the absolute majority of people think that they already have these qualities or do their best to develop them.

Participants of the championships present their original author's works, which are published in the editions of the Academy, and international experts collectively evaluate such researches.

The system of championships in scientific analytics includes the set of interconnected scientific and analytical competitions of different levels, types and formats, which are organized stage by stage within the one-year cycles. The Academy holds championships in all key branches of science.

There are three levels of championships: national level, continental level and the global level.

The next thing is the type. There are three types of championships: alpha-championship, which is held within a certain section of a corresponding branch of science; then there goes the absolute championship, which is held within the entire branch of science; and the last and the most extensive is the mega-championship. It covers the interdisciplinary studies.

Next is the format. There are two formats of championships: a separate stage of the championship and the yearly championship. Every year the Academy holds not less than three stages in every branch.

In addition, when summing up the final results of championships, we divide them into several sections: individual results, results shown by teams (these are the so-called national club championships), and the results of the national teams of different countries.

Based on the results of expert assessment, winners of championships in scientific analytics can be granted several titles. These are the Champion (the winner), the Silver and the Bronze prize-winners. These titles can be granted after separate stages of championships and after the final championship of the year. Titles can be granted to winners of championships in different branches of science at the National, Continental and the Global levels. In order to somehow substantiate these titles the Academy and the World Federation of Scientific Analytics produce special international diplomas and medals.

Visiting the exhibition is free. The exhibition is open 24/7 during the whole year.

Every exhibitor receives international certificates confirming the fact of participation in the exhibition.

Following the results of the exhibition absolute winners and awardees (laureates), as well as winners in certain branches and nominations are determined. They are awarded with international honorary titles, medals, diplomas, honorary marks and special rights and options for preferential participation in projects of the IASHE.

The exhibition is carried out under the auspices of the IASHE (London, United Kingdom) in the remote-interactive format. Exhibitors construct electronic expositions on the special web-resource; organizers ensure free access to these exhibits from the side of the potentially unlimited number of persons concerned and arrange communications between participants of the exhibition. Official location of the exhibition is the legal address of its organizer - the IASHE: 1 Kings Avenue, London, N21 3NA.

Projects on the international goods and services quality certification (according to the ICSQ-775 standard) as well as the international patenting expertise of authors (according to the IOSCEAAD-775 standard) are implemented within the framework of the exhibition on the basis of applications of persons concerned.

TOP 100 LEADERS OF THE INTERNATIONAL QUALITY STANDARD (RATING "TOP 100")



DESCRIPTION AND CONDITIONS

The project "Top 100 leaders of the international quality standard" (Rating "Top 100") was developed and established by the Academy on the initiative of the Institute of Business of the IASHE.

The mission of the project is to identify, mass presentation, promotion and highlight among competing market products those goods and services that are objectively leaders of international quality standards.

The quality leaders within the rating are the relatively best products that are able to best meet the needs of consumers.

The rating expertise can be carried out in three alternative ways:

- during the exhibition "Progressive quality XXI";
- in the process of certification of product quality according to the standard "ICSQ-775";
- based on the results of a wide (open) three-factor examination, which consists of assessments of professional experts, consumers and contextual analysis of information in the media.

To conduct a rating expertise in any specified way, the initiators provide a short description, history of creation and market promotion, as well as technical characteristics of the product, its photographs and video presentation.

All materials required for the rating expertise are published on the information platforms of the Academy to familiarize experts and the general public with such information.

Ratings are formed for certain types of products, sectors of the economy and in absolute (intersectoral) terms.

According to the criterion of the territorial scale of formation, the ratings can be regional, national and international (continental or world).

According to the specified criteria, one and the same product may be included in several ratings of various levels and types.

Ratings are formed in all active nominations. The nomination is activated after a rating expertise in relation to at least one product within the framework of such a nomination.

Three laureates can be determined in each nomination: the winner of the rating, the second and third prize-winners. In addition, all the participants in first hundred of the rating (Top-100) are honorary nominees of the rating.

The laureates of the rating are determined every quarter and based on the results of the calendar year.



DESCRIPTION AND CONDITIONS

Certification on the standard "ICSQ-775" has the international status of authoritative scientific-practical and professional expertise of quality of goods, services, technologies, company management systems and professional knowledge and qualifications. Certification is implemented on the basis of the methodology of professional assessment of objects of certification according to the announced scientifically reasonable criteria and objective joint decision-making following its results.

Operative certification is characterized by significant liberalization of conditions and facilitation of the certification procedure implementation.

Operative certification is carried out in full correspondence with established rules of the ICSQ-775 standard certification taking the below noted differences into account.

In particular, operative certification is carried out only within the expert assessment category of the "Foundation" level.

- Final level of the certification mark is determined by the open expertise. Sectoral specialists accepted by the IASHE can take part in it. General negative conclusion of the open expertise lowers the recommended level of the certification mark given by the Professional Expert Council by 1 grade. General positive conclusion made by 2/3 of the general number of votes rises it by 1 grade. Open expertise takes place during the calendar year after the statement of the general expert mark of the object by the Professional Expert Council.

PATENTING INNOVATIONS ACCORDING TO THE IOSCEAAD-775 STANDARD



DESCRIPTION AND CONDITIONS

Operative patenting - has the status of the authoritative scientific-practical and professional expertise of novelty, superiority, innovativeness and practical applicability of results of creative activity of persons concerned. It is implemented with observance of general principles of the IOSCEAAD-775 standard. At the same time operative patenting is characterized by significant liberalization of terms and facilitation of the patenting procedure implementation.

Operative patenting acts as the international instrument of legal protection and official presentation of the innovation with indication of superiority of its announcement, presentation of instruments of legal support of the determined superiority, as well as open access to the procedure of reasonable impugment of such superiority from the side of persons concerned.

Patenting according to the IOSCEAAD-775 standard is not the direct analog or the substitute of traditional patenting systems used in licensing systems of certain countries. It acts as an alternative and additional instrument of international presentation of innovations, fixation of their authorship and legal copyright protection. Patenting on the IOSCEAAD-775 standard may be implemented by persons concerned together with implementation of traditional mechanisms of copyright protection.

Patenting according to the IOSCEAAD-775 standard allows the significant number of authors from around the world to declare their authorship on the international level, carry out its legalization and protection in terms of inaccessibility (for various reasons) of traditional patenting systems or insufficiency of their resources for proper legalization and copyright protection.

Operative patenting is carried out in strict observance of established rules of patenting according to the IOSCEAAD-775 standard taking into account differences stated below.

In particular, operative patenting is carried out only within the expert assessment category of the "Foundation" level.

Procedure of carrying out the expertise and rules of determination of its results

- The obligatory factor determining the possibility of admission of the innovation to patenting is presentational (preliminary) promulgation of not less than two author's publications revealing the content and analysis of the innovation, submitted within sectoral research analytics championships (the PLATONICK project) of the International Academy of Science and Higher Education (IASHE, London, UK).
- Materials, submitted for the expert assessment and intended for the open access are presented in the relevant section of the website of the IASHE.
- General expert assessment of the object (approval of successful patenting or denial in such statement) and the recommended level of the patenting mark (5-grade system determining the quantity of assigned "innovation quality stars") is carried out by qualified sectoral specialists from around the world (Professional Expert Council) invited by the IASHE.
- Final level of the patenting mark is determined by the open expertise. Sectoral specialists accepted by the IASHE can take part in it. General negative conclusion of the open expertise lowers the recommended level of the patenting mark given by the Professional Expert Council by 1 grade. Positive mark verifies the recommended level. General positive conclusion made by 2/3 of the general number of votes rises it by 1 grade.



PATENTING INNOVATIONS ACCORDING TO THE IOSCEAAD-775 STANDARD



DESCRIPTION AND CONDITIONS

- Every specialist allowed to take part in the open expertise must formulate the reasonable note (argumentative objection to verification of patenting because of absence of the object's patentability criteria) while giving the negative mark. If the note is satisfied by the Professional Expert Council of the IASHE, it may become the basis for denial in patenting of the relevant object.

Within the framework of the patent procedure according to the "IOSCEAAD-775" standard, copyrights can be confirmed and protected even for such intellectual innovations which do not have a completed (final) form. For example, ideas and plots of literary works.

Within the system of activity of the IB accreditation may have personal or product-related formats.

Personal accreditation is directed to determination of the individual status of the person concerned within the system of activity of the IB.

Product-related accreditation has the nature of image verification of correspondence of quality of goods, services and technologies to the generally accepted international quality standard.

Nominations of status (personal) accreditation of relevant persons' achievements: “Administrative thought Leader”, “Top-manager”, “Creator of progress”, “Innovator”, “Promotion strategy”, “Intellectual creation”, “Inspiration”, “Inventor”, “Manager”, “Professional Olympus”.

Nominations of status accreditation of high level of consumer properties of market products (Product accreditation): “Standard of quality”, “Consumers' preferences favourite”, “Market leader”, “Rush demand”, “Innovation”, “Discovery”, “Commodity of the year”, “Service of the year”.



DESCRIPTION AND CONDITIONS

Within the framework of the festivals, interested persons can voluntarily undergo additional procedure of the Competitive Certification under the program of national, continental and world championships in festival art.

The competitive certification under the program of national, continental and world championships in festival art is carried out within the framework of a competitive event (championship), the results of which determine the best participants of the Festival (championships of various levels) of each calendar stage of the Festival (decade, month, quarter) and, in aggregate, of the corresponding year.

Winners and prize-winners of the festivals who participate in the competitive certification, on the basis of the results of the quarter and the year, can additionally become national champions of their countries and continental champions. Winners and prize-winners of the world championship in festival art are determined based on the results of the calendar year of the OAA festival.

The professional expert assessment of participants of the competitive certification is carried out by members of the jury of the Festival.

You can take part in championships of various levels at any time.

Participation in the championship at each stage (event) involves the presentation of two works of art (numbers, performances). It is possible to participate in one or more stages during the year. Rules of the championship - <https://artfestiashe.blogspot.com/p/championships.html>



COST

The amount of payment for participation in the championships at each stage:

- a creative team in the number of performers up to 3 people - € 50.0 from the team; a creative team in the number of performers over 3 people - € 15.0 from each performer.

- a solo performer - € 40.0.

The amount of such payment for a participation in the continental championship is doubled, and for a participation in the world championship - three times.

If an interested person simultaneously participates in two or three championships of the different levels (national, continental, world), such person pays for a participation in each of the championships.

4 INTERNATIONAL EDUCATIONAL CERTIFICATION OF ARTISTIC HEADS AND CREATIVE PERFORMERS



DESCRIPTION AND CONDITIONS

As part of the Festival (the term "Festival" refers to both festivals held by the Institute of Arts of the IASHE), interested heads and individual performers (personally) of creative teams (collectives) or solo performers can undergo the procedure of international certification of the level of skill (qualification).

The certification is an additional program of the Festival, which is not a mandatory element of a participation in the Festival and is carried out only upon a voluntary application of interested parties.

The certification is carried out by the Institute of Arts of the IASHE. In case of a positive passage of the procedure by interested persons, international educational diplomas and IASHE attestation certificates are issued for them. Such documents include data on a volume of an educational load during the certification and results of the certification.

The professional expert assessment of attested persons is carried out by members of the jury of the Festival.

You can take part in the educational certification program at any time.

Participation in the educational certification program at each stage (event) involves the presentation of two works of art (numbers, performances). It is possible to participate in one or more stages during the year.

Possible specializations for which educational certification is carried out:

- for heads of creative teams (collectives):

a) a manager and / or producer of a creative team;

b) a master teacher in different kinds of art: a choreographer, ballet master, director, stage director, tutor, trainer, musicologist, choirmaster, etc. of a creative team (performer);

- for performers:

a) a creative performer of works of art.

5 PROFESSORIAL ATTESTATION FOR ARTISTIC HEADS



DESCRIPTION AND CONDITIONS

Artistic heads of collectives or solo performers automatically and free receive the pedagogical title of the Creative Professor, if the collectives and performers of such heads meet the following requirements:

- they participated in the Festivals at least 10 times;
- according to the results of participation in the Festivals, at least 5 times they became the holders of the Grand Prix of any value ("Gold", "Silver" or "Bronze" Grand Prix);
- they have won at least 3 titles of the winners or prize-winners of the national championship in festival art for any calendar period (quarter or year);
- they have won at least 1 title of the winner or prize-winner at the international level (the continental or world championship in festival art) for any calendar period (quarter or year). In some cases, the Organizing Committee may early assign the pedagogical title of the Creative Professor to artistic heads, whose collectives or performers demonstrate at festivals a high level of progressive artistic creativity and professional skill.
